## CONTACT FORM PRIVACY NOTICE

Dear User, **Beretta Alfredo S.r.l.** cares about your privacy. Data that user can eventually transmit will be stored with methods that guarantee integrity and safety, fully respecting the data confidentiality regulation. We would like to inform you that the *European Regulation 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data* ("GDPR" from now on) provides user protection, with particular regard to personal data processing. 	<b>A. CATEGORIES OF DATA:</b> personal data that are collected may include personal identifying information, contact information and details about your requests.

	C. SOURCE OF PERSONAL DATA: personal data are collected directly from the data subject.
<b>@</b> -	<b>D. PURPOSE AND LEGAL BASIS FOR PROCESSING DATA:</b> personal data are collected and processed for the purpose of giving execution to a specific user request or provide the requested service. The legal basis for the processing is the data subject's consent (Article 6, lett. A).
	<b>E. RECIPIENTS AND CATEGORIES OF RECIPIENTS:</b> according to the listed finalities, your data could be communicated to private third parties, partners, consulting companies, private companies, third-party technical service providers, hosting providers, communication agencies. Your personal data will not be disclosed to the public or, in any case, to an indeterminate number of parties.
× ************************************	<b>F. TRANSFER OF PERSONAL DATA BETWEEN COUNTRIES:</b> your personal data are not transferred to or accessed by entities outside the European Union.

DATA RETENTION PERIOD:</b> in the absence of specific retention periods set out in this policy, your personal data will be retained only for as long as we need it to fulfil the purpose for which we have collected it, according to the "storage limitation principle" (Article 5 of GDPR) and, if applicable, as long as required by statutory retention requirements.

RIGHTS OF THE DATA SUBJECT:</b> each user is always entitled to request the Data Controller to access, correct or delete his data, limit the processing or the possibility of objecting to the processing, requesting data portability, revoking consent to the processing of data, claiming these and other rights provided by the GDPR through a simple communication to the Controller. The data subject can also lodge a complaint with a supervisory authority.
